ZONING BOARD OF ADJUSTMENT MINUTES OF THE MEETING April 20, 2021

The Long Hill Zoning Board of Adjustment met for a Regular Meeting/Hearing via online virtual meeting format using Zoom Webinar.

Paul Mitchell, Esq. appeared on behalf of the Applicant.

Attorney Mitchell explained to the Board that due to the intensity of the past year in real estate transactions the deed for the approved subdivision was not filed with the 120-day allotted timeframe, and the Applicant requests an extension of four (4) months.

During discussion, the Board agreed to extend the timeframe to August 11, 2021.

Upon motion made by Vice Chairman Johnson and seconded by Mr. Rosenberg, the extension request was approved subject to a memorializing resolution by the unanimous votes of Vice Chairman Johnson, Mr. Rosenberg, Mr. Grosskopf, Mr. Malloy and Chairman Gerecht; they being all members present and eligible to vote.
