ORDINANCE PUBLIC HEARING / CONSIDERATION OF ADOPTION:

ORDINANCE #301-12 CALENDAR YEAR 2012 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.0% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Long Hill in the County of Morris finds it advisable and necessary to increase its CY 2012 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 3.5% increase in the budget for said year, amounting to \$368,979.45 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Long Hill, in the County of Morris, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2011 budget year, the final appropriations of the Township of Long Hill shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by <u>3.5</u> %, amounting to \$368,979.45, and that the CY 2011 municipal budget for the Township of Long Hill be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

WHEREAS, the term of the Township Municipal Court Judge expires on May 3, 2012; and

WHEREAS, the judge has continues to serve the Municipal Court; and

WHEREAS, the governing body wishes to re-appoint James Bride as the Judge of the Municipal Court of the Township of Long Hill;

NOW, THEREFORE, BE IT RESOLVED by the governing body of the Township of Long Hill, County of Morris, New Jersey that James Bride is hereby re-appointed Municipal Court Judge pursuant to N.J.S.A. 2B:12-4 and in accordance with the following terms and conditions:

Term: Three (3) years commencing May 4, 2012 and ending May 3,

2015, and until a successor is appointed and qualified.

Salary: the Judge's current salary shall be \$27,157.

RESOLUTION 12-165 AUTHORIZING LEASE WITH LONG HILL TOWNSHIP LITTLE LEAGUE

WHEREAS, N.J.S.A. 40A:12-14 provides that:

"Any . . . municipality may lease any real property [and] [I]n the case of a lease to a public body, the lease may be upon such terms and conditions and for nominal or other consideration as the governing body of the . . . municipality shall approve by ordinance or resolution."

WHEREAS, there is an existing long term lease between Long Hill Township (the "Township") and the Long Hill Township Little League (the "Little League") that cannot be located; and

WHEREAS, hundreds of Township boys and girls participate in the Little League's baseball and softball leagues; and

WHEREAS, the Little League is run by Township residents who serve as volunteer managers, coaches and members of the board of directors; and

WHEREAS, the Township Committee has determined that continuation of the lease with the Little League is in the best interest of the Township and its residents;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Long Hill in the County of Morris, State of New Jersey that the proposed lease with the Long Hill Township Little League for a term of fifty (50) years, with 4 five-year options is hereby approved and the Mayor and Clerk are hereby authorized to execute that lease on behalf of the Township.

RESOLUTION 12-166 APPROVING SPECIAL EVENT LICENSE [KOINONIA ACADEMY]
