- Thank you to all our volunteers and to Lisa Scanlon and Bob English for teaching the CPR/First Aid classes.
- FEMA Storm Reinbursement The latest check received was for \$17,500 making a total of \$65,333 received. We are still awaiting the largest check for \$158,956.

Comm. Schuler:

CAC met last month to discuss upgrading the cameras and feed system in the courtroom. The
question to be addressed by the Township Committee in the near future is whether the Township
wants to move forward with live streaming only or keep the bulletin board/cable viewing and the
live streaming or just keep the bulletin board/cable access.

Comm. Rae:

WHEREAS, Somerset County and Morris County, in coordination with NJTPA and NJDOT is desirous of completing the Local Concept Development phase and proceeding to the preliminary engineering and final design phases; and

WHEREAS, to qualify to receive federal funding for the preliminary engineering and final design phases, a resolution of support of the Local Concept Development Study from Long Hill Township is desired for inclusion within the Local Concept Development phase project documentation.
