WHEREAS, N.J.A.C. 7:10A-1.10 goes on to provide that "The licensed operator shall be in charge of the operation of the system . . . "; and

WHEREAS, the Township was unable to hire a new plant operator and was, therefore, forced to award an emergency contract to Veolia Water North American Operating Systems LLC to serve as plant operator through December 31, 2018; and

WHEREAS, the Township Committee has begun the process of placing a public question on the November 5, 2019 general election ballot to authorize the sale of the Township Wastewater Treatment System to a private sector enterprise; and

WHEREAS, if the public question to sell the Wastewater Treatment Plant is defeated, the Township will still need a licensed plant operator to run its Wastewater Treatment System; and

WHEREAS, the Open Public Contracts Law at N.J.S.A. 40A:11-5 provides that, "A contract for the provision of wastewater treatment services entered into pursuant to [N.J.S.A. 58:27-19 et seq] may be negotiated and awarded by the governing body without public advertising for bids and bidding therefor and may be awarded by resolution of the governing body"; and

WHEREAS, the New Jersey Wastewater Treatment Public-Private Contracting Act, N.J.S.A. 58:27-19 sets forth in detail the procedures that must be followed in order for a public entity to enter into a contract with a private firm for the provision of wastewater treatment services; and

WHEREAS, as part of that process, the Township must pursue a Request for Proposals ("RFP") and must publish a notice of its intent to enter into a contract; and

WHEREAS, after it has received proposals, the statute authorizes the Township to select one qualified proposal from among those submitted and to negotiate a contract with the private firm that submitted the selected proposal; and

WHEREAS, after following the procedures and timetable set forth in the statute, the Township Committee must hold a public hearing on the proposed contract that has been negotiated; and

WHEREAS, the Township must then adopt an ordinance approving the proposed contract and obtain the approval of the New Jersey Department of Environmental Protection in order to enter into the proposed contract;

NOW, THEREFORE, BE IT RESOLVED as follows:

- 1. The Township Clerk is hereby authorized to publish a notice of the Township's intent to enter into a contract with a private firm for the provision of wastewater treatment services pursuant to N.J.S.A. 58:27-19, et seq in at least one newspaper of general circulation in the Township at least sixty (60) days prior to conducting the public hearing required under section 6 of N.J.S.A. 58:27-23.
- The notice shall specify a deadline chosen by the Clerk which shall be not less than thirty (30)
 days from the date of the publication of the notice for the submission of proposals by private
 firms.
- The public hearing on a proposed contract with a private firm for the provision of wastewater treatment services shall be held at 7:30 p.m. on Wednesday, July 17, 2019.
- 4. The Township Clerk, the Township Administrator and all other Township officials shall comply with all requirements and deadlines set forth in the New Jersey Wastewater Treatment Public-Private Contracting Act, N.J.S.A. 58:27-19, whether or not set forth in this resolution.

- Request Expanded Deck at Baseball Field on Poplar Mayor Dorsi left the room for this portion of the discussion. Scott Lavender and Mead Briggs spoke to the Committee about the Baseball & Softball Association and how it played an important part in the Community and was a valuable resource to the lifestyle and branding of the Long Hill Sports. They noted that they expected the expansion of the deck to be used by many of the residents as well as visiting team supporters and that other groups such as the Multiple Myeloma Foundation and Girl Scouts have also used the pavilion. Mr. Briggs noted that the association works hard to keep the fees low so anyone that wants to participate can and how that leaves them with only a small reserve. Ms. Malool reviewed the quote she had received version A was \$26,000 and would keep the foundation framing intact, version B was \$29,000 and would replace the foundation framing. There would also be an additional cost of about \$3000 to remove a tree. The Committee decided to introduce an Ordinance at the next meeting for \$29,000. Comm. Meringolo and Comm. Section 3 The capital budget or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services, are on file with the Township Clerk and are available for public inspection.

Section 4 This ordinance shall take effect after final adoption, as provided by law.
