WHEREAS, the Mayor and Township Committee of the Township of Long Hill have authorized a Length of Service Award Program (LOSAP) for the Long Hill Volunteer First Aid Squad, Stirling Volunteer Fire Department and the Millington Volunteer Fire Department; and

WHEREAS, the Long Hill Volunteer First Aid Squad, the Stirling Volunteer Fire Department and the Millington Volunteer Fire Department have collectively certified 82 members eligible for a contribution based on their service during the year 2018; and

WHEREAS, eligible members are not required to participate in LOSAP, however if they wish to participate, a participant agreement was requested to be submitted;

WHEREAS, the maximum contribution for each member for the 2018 service year has been determined to be \$1,265.00.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Long Hill, as follows:

1. The attached certified list of members for each participating emergency service organization is hereby approved.

2. The approved list of active certified volunteer members shall be returned to each emergency service organization and posted for at least 30 days for review by the membership.

3. An active volunteer member whose name does not appear on the approved certification list or who is denied credit for prior service must appeal within 30 days of the posting of the list. The appeal must be in writing and mailed to the Township Clerk. The Township Committee will then investigate the appeal, which is subject to judicial review. Once the 30 days have elapsed, and subject to holding any members being appealed, payment shall be made to the individual members' accounts in the deferred income program administered by Lincoln Financial, the LOSAP Trustee, up to the sum of \$96,127.00 as per the list submitted by the Fire Companies.

TOWNSHIP OF LONG HILL RESOLUTION 19-273 AUTHORIZING A NEGOTIATED CONTRACT FOR THE CONSTRUCTION OF

THE PEDESTRIAN PATH AT THE MATTHEW G. KANTOR MEMORIAL PARK

WHEREAS, bids were received by the Township Clerk on June 5, 2019 for construction of the Matthew G. Kantor Memorial Park pedestrian path; and

WHEREAS, the only bid was received from V&K Construction; in the amount of \$89,000, which was \$24,000 higher than the cost estimate for the project prepared by the Township Engineer and

WHEREAS, the bid was not reasonable as to price, on the basis of that cost estimate prepared by the Township Engineer, and was therefore rejected; and

WHEREAS, bids were received by the Township Clerk for a second time on Sept 11, 2019 for construction of the Matthew G. Kantor Memorial Park pedestrian path; and

WHEREAS, two bids were received on this occasion and they were both rejected because they both exceeded the estimated cost for the project and were higher than the bid submitted by V&K Construction on June 5, 2019; and

WHEREAS, N.J.S.A.40A:11-5 provides that:

"Any contract the amount of which exceeds the bid threshold, may be negotiated and awarded by the governing body without public advertising for bids and bidding therefor and shall be awarded by resolution of the governing body if:

(3) Bids have been advertised pursuant to section 4 of P.L.1971, c.198 (C.40A:11-4) on two occasions and ... the governing body has rejected the bids on two occasions because it has determined that they are not reasonable as to price, on the basis of cost estimates prepared for or by the contracting agent prior to the advertising therefor, ... a contract may then be negotiated and may be awarded upon adoption of a resolution by a two-thirds affirmative vote of the authorized membership of the governing body authorizing the contract; provided, however, that:(i) A reasonable effort is first made by the contracting agent to determine that the same or equivalent goods or services, at a cost which is lower than the negotiated price, are not available from an agency or authority of the United States, the State of New Jersey or of the county in which the contracting unit is located, or any municipality in close proximity to the contracting unit;(ii) The terms, conditions, restrictions, and specifications set forth in the negotiated contract are not substantially different from those which were the subject of competitive bidding pursuant to section 4 of P.L.1971, c.198 (C.40A:11-4); and(iii) Any minor amendment or modification of any of the terms, conditions, restrictions, and specifications, which were the subject of competitive bidding pursuant to section 4 of P.L.1971, c.198 (C.40A:11-4), shall be stated in the resolution awarding the contract; provided further, however, that if on the second occasion the bids received are rejected as unreasonable as to price, the contracting agent shall notify each responsible bidder submitting bids on the second occasion of its intention to negotiate, and afford each bidder a reasonable opportunity to negotiate, but the governing body shall not award the contract unless the negotiated price is lower than the lowest rejected bid price submitted on the second occasion by a responsible bidder, is the lowest negotiated price offered by any responsible vendor, and is a reasonable price for goods or services"; and

WHEREAS, Township Administrator has negotiated a contract with V&K Construction to construct the path using permeable asphalt which is more desirable than the material set forth in the bid specifications for \$78,000, which is \$11,000 less than its June 5 bid; and

WHEREAS, the Township Administrator has complied with all of the requirements of *N.J.S.A.40A:11-5* in negotiating this contract

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Long Hill in the County of Morris, State of New Jersey, as follows:

- 1. The contract for the construction of the Matthew G. Kantor Memorial Park pedestrian path is hereby awarded to V& K Construction in the amount of \$78,000, in accordance with the bid specifications, as modified, and the terms of the negotiated agreement.
- 2. The Mayor and Clerk are hereby authorized and directed to execute the contract for the construction of the Matthew G. Kantor Memorial Park pedestrian path.

TOWNSHIP OF LONG HILL RESOLUTION 19-274 TERMINATING 1993 INTERLOCAL SERVICES AGREEMENT WITH BERKELEY HEIGHTS FOR SHARED USE OF AERIAL TRUCK

WHEREAS, Long Hill Township (the "Township") entered into an Interlocal Services Agreement with Berkeley heights on December 29, 1993 for the purpose of sharing an aerial truck; and

WHEREAS, the Township is now going to sell its interest in the truck to Berkeley Heights;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Long Hill in the County of Morris, State of New Jersey that the December 29, 1993, Interlocal Services Agreement with Berkeley Heights for the purpose of sharing an aerial truck is hereby terminated, effective immediately.

2. Employee benefits and all other terms and conditions of employment shall remain the same as they are in her current position, and she shall remain subject to the Township Employee Personnel Policies and Procedures.

AN ORDINANCE MAKING TITLE 39 OF THE NEW JERSEY STATUTES APPLICABLE TO THE NEW EMPLOYEE PARKING LOT (BLOCK 10502, LOT 1) AT SHOP RITE AND SUPPLEMENTING AND AMENDING CHAPTER VII OF THE TOWNSHIP CODE ENTITLED "TRAFFIC"

WHEREAS, the Zoning Board of Adjustment ("Board") approved a development application (No. 16-07Z) filed by Village Super Market, Inc. ("Shop Rite") to utilize a residentially zoned parcel known as Block 10502, Lot 1.01 (formerly known as Block 10502, Lot 1) on the Township tax maps for employee parking; and

WHEREAS, condition 1 of the Board's resolution provided that the parking shall only be utilized for employee parking between the hours of 8:00 a.m. and 8:00 p.m.; and

WHEREAS, Condition 14 of the Board's resolution required Shop Rite to "give the Township Title 39 authority/jurisdiction over motor vehicles circulating and parking on the shopping center lot [Block 10501, Lot 1] ("shopping center lot") and . . . provide same to [Block 10502, Lot 1] [now designated as Block 10502, Lot 1.01 as a result of a recorded deed of consolidation]; and

WHEREAS, Title 39 was previously made applicable to the shopping center lot pursuant to paragraph "c" of 7-38.3 of the Township Code entitled "Regulations for the Movement and the Parking of Traffic on All Other Private Property"; and

WHEREAS, the attorneys for Shop Rite, in accordance with the provisions of N.J.S.A. 39:5A-1, submitted a March 13, 2019 letter requesting that Title 39 of the Revised Statutes be made applicable to Block 10502, Lot 1.01, as shown on the site plans submitted with their letter;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Long Hill in the County of Morris, New Jersey that Chapter VII of the Township Code entitled "Traffic" is hereby supplemented and amended as follows:

Section 1. Subsection 7-38.3 of the Township Code entitled "Regulations for the Movement and the Parking of Traffic on All Other Private Property" is supplemented and amended by adding a new subparagraph "8" paragraph "c" which reads as follows:

"7-38.3 Regulations for the Movement and the Parking of Traffic on All Other Private Property.

"In accordance with the provisions of N.J.S.A. 39:5A-1, the regulations of Subtitle 1 of Title 39 are hereby made applicable to the properties listed below.

c. Property.

Lord Stirling Shopping Center 1153 Valley Road Stirling, N.J. 07980

1. Parking. All vehicles must park in the designated area between the painted lines.

- 2. Speed Limits. The speed limit for both directions of traffic on roads and parking lots shall be 15 m.p.h.
- 3. Restricted Parking. No person shall park a vehicle anytime upon any of the streets or parts of the streets described below.

ORDINANCE #448-19

AN ORDINANCE LOWERING THE AGE FOR JUNIOR FIREFIGHTERS AND SUPPLEMENTING AND AMENDING CHAPTER II OF THE TOWNSHIP CODE ENTITLED "ADMINISTRATION"

STATEMENT OF PURPOSE: To lower the minimum age for Junior Fire Fighters from sixteen (16) to fourteen (14) to be consistent with State law

WHEREAS, Ordinance 28-86 (codified as Township Code section 2-15.7) established a Junior

Firefighter's Auxiliary, pursuant to the provisions of N.J.S.A. 40A:14-95, and went on to provide that "No

person shall be eligible for membership in a Junior Firefighter's Auxiliary who is less than sixteen (16) or more than eighteen (18) years of age."

WHEREAS, P.L. 1999, c. 318, effective January 6, 2000, amended N.J.S.A. 40A:14-95 by

lowering the minimum age for Junior Fire Fighters from sixteen (16) to fourteen (14); and

WHEREAS, the fire companies would like to amend the Township Code to be consistent with

State law;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Long Hill

in the County of Morris, New Jersey, that Chapter II of The Township Code Entitled "Administration" is

hereby supplemented and amended as follows:

Section 1. Subsection 2-15.7, entitled, "Junior Firefighter's Auxiliary" in section 2-15 entitled,

"Fire Department" is supplemented and amended to read as follows:

"2-15.7 Junior Firefighter's Auxiliary.

Pursuant to the provisions of N.J.S.A. 40A:14-95 the Fire Companies may establish Junior Firefighter's Auxiliaries. No person shall be eligible for membership in a Junior Firefighter's Auxiliary who is less than <u>fourteen (14)</u> sixteen (16) or more than eighteen (18) years of age. Such persons shall be required to obtain permission to join the auxiliary from their parents or guardian. Such permission shall be in writing and acknowledged or approved in the manner required by law for deeds to real estate to be recorded. Members of the Junior Firefighter's Auxiliary shall be provided with the same insurance coverage as provided for the regular volunteer firefighters of the Company. The Township Committee shall adopt by resolution the rules and regulations promulgated by the respective Companies. No junior firefighter shall be required to perform duties which would expose him to the same degree of hazard as a regular member of the volunteer Fire Company. <u>Activities of Junior Firemen under 16 years of age shall be limited to (1) attending meetings of the Junior Firemen's Auxiliary; (2) receiving instruction; (3) participating in training that does not involve fire, smoke, toxic or noxious gas, or hazardous materials or substances; and (4) observing firefighting activities, while under supervision."</u>

Section 2. Any and all other ordinances or parts thereof in conflict or inconsistent with any of the

terms hereof are hereby repealed to such extent as they are so in conflict or inconsistent.

Section #3. In case any article, section or provision of this ordinance shall be held invalid in any court of competent jurisdiction, the same shall not affect any other article, section or provision of this ordinance except insofar as the article, section or provision so declared invalid shall be inseparable from

the remainder or any portion thereof.

Section 4. This ordinance shall take effect immediately upon final passage and publication as

required by law.

7-14 PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS.

No person shall park a vehicle at any time upon any streets or parts thereof described.
