RESOLUTION 21-323

A RESOLUTION CANCELING RESOLUTION 21-263 WHICH MADE AN EMERGENCY APPROPRIATION FOR REPAIRS TO THE POLICE STATION PURSUANT TO N.J.S.A. 40A:4-48 AND

BY CHANGING THE SOURCE OF FUNDS FOR RESOLUTION 21-253 WHICH AUTHORIZED AN EMERGENCY CONTRACT WITH GOLDCON, INC.FOR REPAIRS TO THE POLICE STATION (AS PREVIOUSLY CHANGED BY RESOLUTION 21-264)

WHEREAS, at a special meeting on September 27, 201, the Township Committee adopted Resolution 21-253 authorizing an emergency contract with Goldcon, Inc. to repair the damage to Police Headquarters caused by Tropical Storm Ida for an amount not to exceed \$350,000 from the Storm Recovery Trust Fund; and

WHEREAS, the Township Committee thereafter adopted Resolution 21-263 at its October 6, 2021, meeting making an emergency appropriation pursuant to N.J.S.A. 40A:4-48 in the amount of \$438,000 for repairs to the police station: and

WHEREAS, the Township Committee also adopted Resolution 21-264 at its October 6, 2021, meeting "Amending Resolution 21-253 which Authorized an Emergency Contract with Goldcon, Inc. for Repairs to the Police Station by Increasing the "Not to Exceed" Amount From \$350,000 To \$ 438,000 and by Changing the Source of the Funds from the Storm Recovery Trust Fund to an Emergency Appropriation"; and

WHEREAS, at its meeting on November 10, 2021, the Township Committee then adopted Ordinance 483-21 entitled "Bond Ordinance Providing for the Remediation of the Police Headquarters in and by the Township of Long Hill, in the County of Morris, New Jersey, Appropriating \$461,000 therefor and Authorizing the Issuance of \$438,000 Bonds or Notes of the Township for Financing Such Appropriation"; and

WHEREAS, the Township Committee wishes to change the source of funds again for the Goldcon contract from the emergency appropriation authorized by Resolution 21-263 to Bond Ordinance 483-21:

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Long Hill in the County of Morris, State of New Jersey, as follows:

- 1. Resolution 21-263 which made an emergency appropriation in the amount of \$438,000 for repairs to the police station pursuant to N.J.S.A. 40A:4-48 is hereby repealed and the emergency appropriation is canceled.
- 2. The source of funds for the contract with Goldcon, Inc. for emergency repairs to the police station is hereby changed from the emergency appropriation made by Resolution 21-263 (now repealed) to Bond Ordinance 483-21.

RESOLUTION 21-324 A RESOLUTION INCREASING APPROPRIATION FOR EMERGENCY POLICE TRAILERS BY \$20,000 TO A TOTAL OF \$55,000

WHEREAS, at its September 8, 2021, meeting, the Township Committee authorized the leasing of two trailers from Will Scott for use by the police department during the time that police headquarters could not be used because of damage resulting from Hurricane Ida at a cost of \$35,000; and

WHEREAS, repairs to police headquarters are ongoing and, as a result, the police department needs the trailers for an additional period of time; and

WHEREAS, the Mayor, as the person responsible for determining and confirming the existence of an emergency and that the provisions for emergency purchasing pursuant to *N.J.S.A. 40A:11-6* may be implemented, has determined that the emergency which necessitated the leasing of these trailers has not

ended.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Long Hill in the County of Morris, State of New Jersey that

- 1. The amount appropriated for the trailers being used by the police department is hereby increased from \$35,000 to \$55,000 and the leases are hereby extended.
- 2. This contract shall be charged to budget line item(s) T-12-0278-00999-6-00000. The certification of available funds by the Financial Officer shall be attached to the original of this resolution and shall be maintained in the files of the Township Clerk.
