RESOLUTION 23-092 APPOINTING INTERIM TOWNSHIP ADMINISTRATOR

BE IT RESOLVED by the Township Committee of the Township of Long Hill in the County of Morris, State of New Jersey, that Randy Bahr is hereby appointed as the Interim Township Administrator, effective April 17, 2023, under the following terms and conditions:

- 1. Bahr shall serve as the Township Administrator pursuant to Article II of the Township Code, as authorized by *N.J.S.A.* 40A:9-136.
- 2. As Township Administrator, Bahr shall have the powers and duties set forth in subsection 2-5.6 of the Township Code.
- 3. Bahr shall serve at the pleasure of the Township Committee.

RESOLUTION 23-093

AUTHORIZING PROFESSIONAL SERVICES CONTRACT WITH SUPLEE, CLOONEY & COMPANY FOR INTERIM TOWNSHIP ADMINISTRATOR SERVICES

WHEREAS, the Township of Long Hill has a need to acquire the services of an interim Township Administrator; and

WHEREAS, the Finance Officer has determined and certified in writing that the value of the acquisition will exceed \$17,500; and

WHEREAS, contracts for professional services may be awarded without public bidding pursuant to *N.J.S.A.* 40A:11-5(1)(a)(I); and

WHEREAS, the Chief Financial Officer has certified in writing the availability of adequate funds to pay the maximum amount of this contract; and

WHEREAS, the contractor has submitted a proposal dated March 16, 2023; and

WHEREAS, the contractor has completed and submitted a Business Entity Disclosure Certification

NOW, THEREFORE, BE IT RESOLVED by the Council of the Township of Long Hill, in the County of

Morris, State of New Jersey, as follows:

- 1. A professional services contract is hereby awarded to Suplee, Clooney & Company, a New Jersey partnership, having offices at 308 East Broad Street, Westfield, New Jersey, to provide interim township administrator services, in accordance with its proposal, for the following consideration: \$240,000, which is to be prorated for the balance of 2023, and which shall be payable in monthly installments of \$20,000.
- 2. The Business Disclosure Entity Certification and the Determination of Value shall be placed on file with this resolution, and that notice of these awards be advertised once in the *Echoes Sentinel*.
- 3. The Contractor shall secure and maintain insurance with the following minimum limits:

Professional Liability/Malpractice \$1,000,000.00
Comprehensive General Liability \$1,000,000.00
Comprehensive Automobile Liability \$1,000,000.00
Workmen's Compensation Statutory

The certificates of insurance shall be acceptable to the Township Risk Manager and the Township Attorney.

- 4. The Township Clerk in accordance with the provisions of N.J.S.A. 40A:11-5(1)(a)(I), is directed to publish a notice once in the official newspaper stating the nature, duration, service and amount of this contract.
- 5. These contracts shall be charged to budget line item(s)3-01-0020-00100-2-00211 and 3-010020-00130-2-00211. The certification of available funds by the Financial Officer shall be attached to the original of this resolution and shall be maintained in the files of the Township Clerk.
